Course Description:

Designed for the student who would like to become an effective online researcher. Students will learn to select and effectively use appropriate research tools - such as subscription databases, online catalogs, search engines, online directories, meta-search engines, subscription databases, and online catalogs - for specific information needs. Students will develop search strategies and express their research questions in relevant search terms. In addition, they will evaluate information and create citations in accordance with style manuals. Ethical issues about information will also be introduced. Familiarity with basic microcomputer operation is strongly recommended.

Course Objectives:

Upon successful completion of the course students will be able to:

- a. Describe how information competency can enhance their academic and personal lives.
- Identify and effectively use various information search tools, including subscription databases, catalogs, search engines, directories, and meta-search engines.

- c. Distinguish appropriate search tools necessary for specific information needs.
- d. Construct and implement effective designed search strategies by choosing appropriate search terms, including narrower terms, broader terms, related terms, and synonyms.
- e. Create a search strategy using electronic search techniques, such as Boolean logic, phrase searching, field searching, and other methods.
- f. Create common citation formats
- g. Understand ethical and legal issues about using information.
- h. Critically evaluate the source, quality, and relevancy of information.
- i. Demonstrate effective research skills.
- j. Identify appropriate information sources for specific information need.

Student Learning Outcomes

- a. Refine a research topic by broadening or narrowing the subject matter.
- b. Develop search strategies in order to locate information effectively.
- c. Use online catalogs to locate books.
- d. Use electronic databases and the Internet to locate information including periodical articles.
- e. Document retrieved information in accordance with established style manuals.
- f. Evaluate information resources for their appropriateness for academic research.
- g. Compare various libraries to determine which would most likely have the information they are seeking.

Required Computer Skills and Equipment:

You are required to either have or have access to a computer with an Internet connection; high-speed connection is highly recommended. You must have an email account and be familiar with receiving and sending emails that have attached documents. You are also required to have basic keyboarding, internet, and word processing skills.

Many students enjoy the convenience of an online course from their computers at home. If you do not have a home computer with internet access you are encouraged to utilize the computers in the Learning and Technology Resource Center. This includes the **Library** where computers are on a first-come, first-serve basis and the **Technology Mall**. Keep in mind that using these computers takes pre-planning as they are in high demand.

Software requirements include word processing software (do not use Apple's pages) and multimedia software such as **Windows Media Player**, **Quicktime for Windows** or **Quicktime for Mac**. You will also need the latest version of **Adobe Reader** and **Adobe Flash**. The Library and Tech Mall computers all fill these requirements.

Planning Your Time

This is a 1 unit course over **8 weeks**.
